West Alabama Region 2 Map

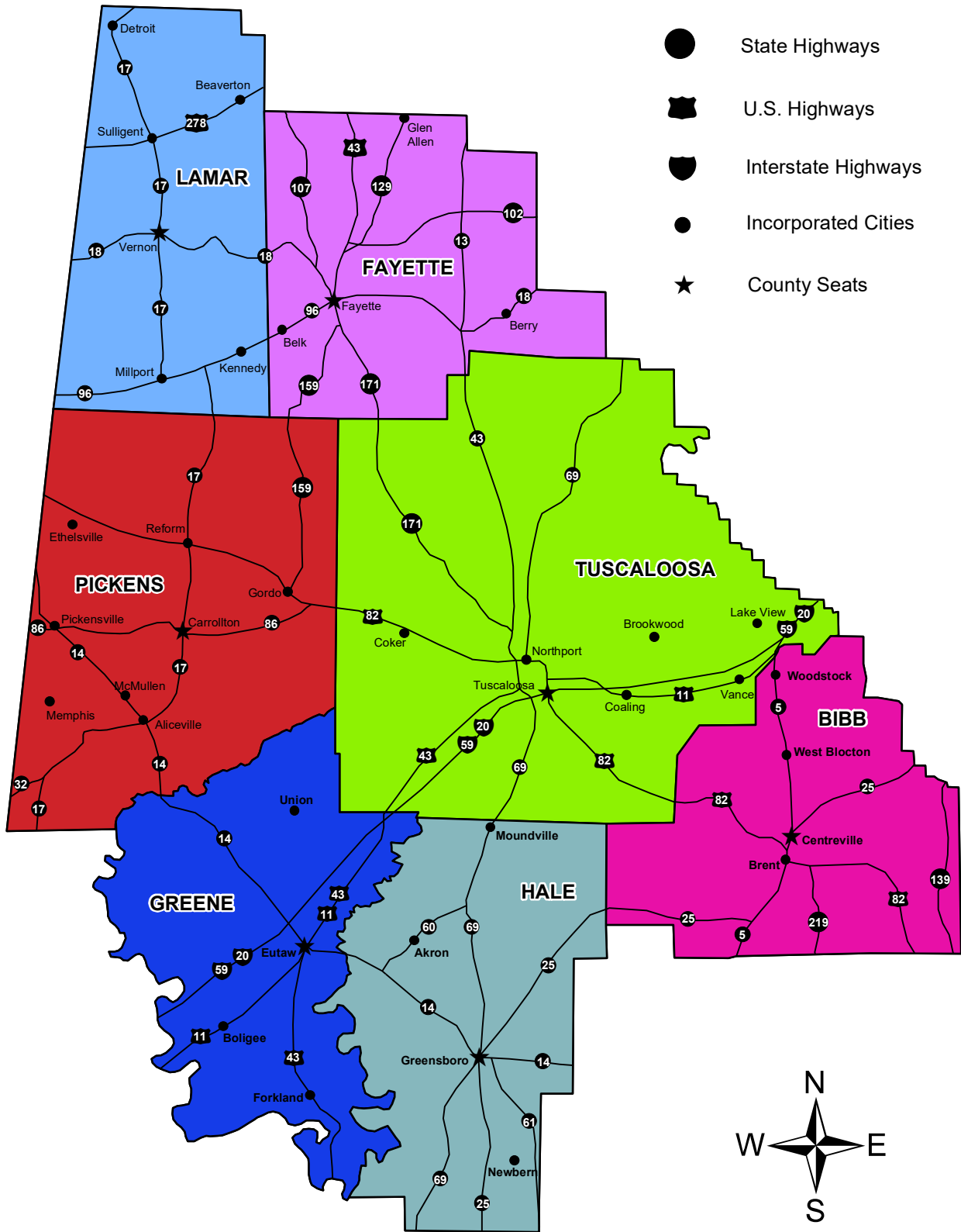
