WHEREAS, the West Alabama Regional Commission has prepared the Work Program - Fiscal Year 2021 outlining the tasks necessary to accomplish the goals of the cooperative planning process and the Rural Planning Organization; and

WHEREAS, the Work Program has been duly reviewed, discussed, and approved by the RPO; now

THEREFORE, BE IT RESOLVED, this 14<sup>h</sup> day of August 2020 that the West Alabama RPO does hereby adopt and endorse the Work Program - Fiscal Year 2021 as the guide for tasks to be completed for the cooperative planning process.
